Attached is a Formal Application for Full Tribal Citizenship. It is the first step in obtaining enrollment in the Patawomeck Indian Tribe of Virginia. There is a non-refundable fee of \$125.00. The fee is per family living in the same household. All applicants 18 and over must pay the \$125.00 application fee.

Currently, we are only accepting full citizenship applications. We are attempting to alleviate the backlog quickly and then continue with all other applications thereafter. The applicant (18 and over) must attend a combination of any 3 separate Tribal events consisting of quarterly meetings and volunteering at Tribal events. If the applicant is under 18, the applicant's parent or guardian must attend a combination of 3 separate events consisting of quarterly meetings and volunteering at Tribal events. Please read the application instructions fully before you begin the application. When we receive your application, the Enrollment Coordinator will review it to make sure all documentation has been included and may contact you if additional information is needed. The Enrollment Coordinator will then present the application to the Tribal Council for evaluation at their scheduled meetings. If the Tribal Council votes to approve your application for enrollment, you will then receive a Tribal Card, and your name will be included on the Official Tribal Rolls. The application process does not have a timeline and may require significant time to evaluate.

If you are a parent or guardian of any child under 18 years of age you may apply for citizenship for that child. The application must be signed by the minor's legal guardian. All full tribal citizens can vote in tribal elections once they have reached the age of 18.

The Patawomeck Indian Tribe of Virginia does not have a genealogist on staff to do your ancestry research. The burden of proof is the responsibility of the applicant.

If you are approved for citizenship, you will be expected to provide volunteer services to the Tribe and participate in the Tribal community.

PLEASE READ ALL INSTRUCTIONS BEFORE STARTING

A. INSTRUCTIONS FOR THE APPLICANT FOR ENROLLMENT

1. Applicant must fill out this form digitally or print legibly in Black or Blue ink and complete all information.
2. Applicant **must** have a direct line ancestor(s) who lived in the Stafford County, VA region and is listed on the 1860 Census for that region with known Patawomeck Heritage.
3. The applicant **must** have a direct line ancestor(s) who interacted with the core community in the Stafford County, VA region in the twentieth century.
4. Application **must** be signed. Digital or wet signatures are permitted. If the applicant is under the age of 18, the application must be signed by the legal guardian or parent of the applicant.

B. INSTRUCTIONS FOR 6 GENERATION CHART (Lineage Chart)

1. Applicant must fill out this section digitally or print legibly in Black or Blue ink and complete all information.
2. Applicant is required to complete the lineage chart six generations back. Please include tribal number, if known, for any enrolled Patawomecks on the chart.
3. (Optional) Please list the applicant's children, siblings, and spouses with their information on the Additional Lineage information sheet.
4. The more lineage information submitted with the application, the better. If you must provide more than 6 generations, please follow the format of the Lineage Chart. Please list any children from known unions including births, deaths, marriages, and divorce information and county/state of the event. Please indicate to which union the children belong. If more space is needed use the back of the lineage chart or a separate sheet of paper.
5. Please include maiden names for all women listed on the chart.
6. In the rest of the lineage chart, add as much information as possible, i.e. birth date, county/state of birth, marriage date, place of marriage, death date, county /state of death, burial site, etc. If information is not known, please mark unknown.
7. List the name(s) of applicant's spouse(s) from marriage(s) in designated area.
8. (Optional) List all siblings of applicant with dates of birth, marriage, death, and county/state of the event. If more space is needed, please use the back of the lineage chart or a separate sheet of paper.
9. Applicant must list their 1860 Ancestor as described above in A.2 on the lineage chart.

UPON COMPLETION OF THE APPLICATION FOR ENROLLMENT AND THE LINEAGE CHART

1. Applicant **must** attach a COPY of their birth certificate. If a birth certificate was not issued, then any other acceptable copies of legal documents that will prove your identity to the Patawomeck Tribe can be submitted in place of the Birth Certificate.
2. You must document and support all connections using birth/death/marriage certificates, if possible. If you are not sure if what you have is sufficient, send your documentation, and you will be contacted if more information is needed.

The Patawomeck Indians of Virginia are a Descendancy-based Tribe. In order to qualify for Full Tribal citizenship, the applicant must provide the Patawomeck Council with a detailed genealogy, along with documentation demonstrating descent from a Patawomeck Indian. Additionally, the applicant must have a direct-line ancestor(s) on the 1860 census in the Stafford County, Virginia region and demonstrate connections between their direct-line ancestor(s) and the core Patawomeck community in the twentieth century. All decisions on what constitutes sufficient evidence for these requirements is at the sole discretion of the Tribal Council.

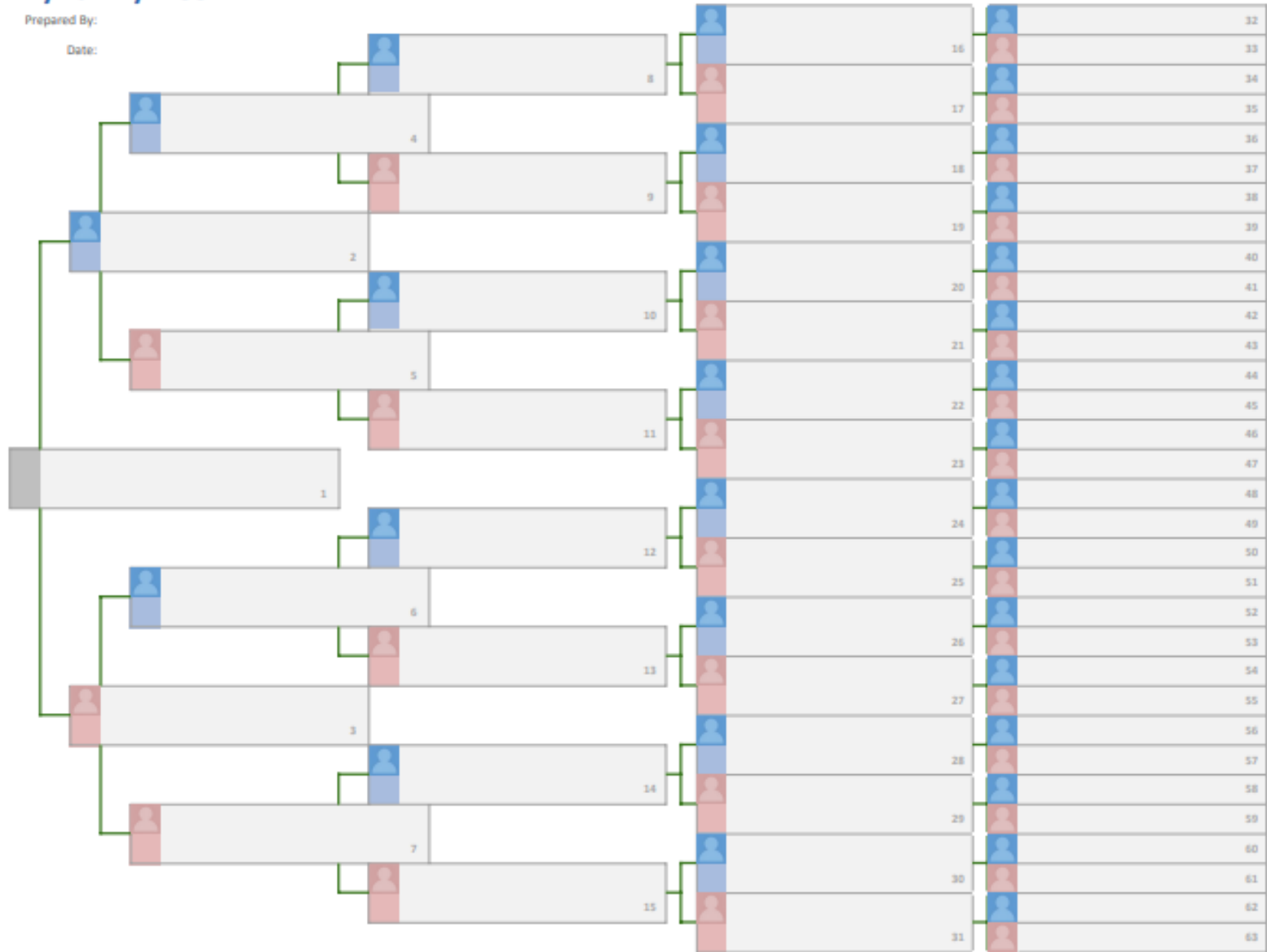
